It goes without saying that literature, individual and society are deeply and densely intertwined. At the same time literature is a formal, conceptual and existential construct with every author having his/her own unique way of presenting his world and universe. A reading of Rainer Maria Rilke's essays on the role and status of art in the society, Milan Kundera's *Art of the Novel* (first published in 1986) and Michael Maar's *Die Schlange im Wolfspelz. Das Geheimnis großer Literatur* (2020) would be the point of departure for discussions on the literary discourse. The course includes a reading of literatures from a broad spectrum of languages, genres, times and spaces.
