CIRCULAR

In view of increasing number of Covid-19, all stakeholders of the University are hereby informed that the recently many COVID-19 positive cases are detected from the different areas of the University.

In view of above, all residents of the campus are requested to comply with the following precautionary measures in letter and spirit.

1. It came to notice that some of the Campus residents are hiding their Inter State travel movement history; it may cause spreading of Covid-19 in the Campus. All residents are strictly instructed to fill the Self Declaration Form (SDF) available with the Security Department before entering the campus and follow the Covid-19 quarantine protocols.
2. It came to notice that some of campus resident those identified/tested Covid positive are hiding the information from university administration; it may cause spreading of Covid-19 in the Campus. Henceforth, it is instructed that if someone tested positive he/she may immediately inform the same at telephone numbers- 011-26704029, 8130573744.
3. Maintain proper social distancing and use of face mask and other protective gears.
4. Avoid non essential movements in the Campus and stay safely at home.
5. Avoid inviting friends and relatives in the Campus and also avoid to visit one another home of neighborhood in campus.
6. Avoid mass gathering in the Campus.
7. The residents of Campus may cooperate with Security officials.
8. Social distancing may be followed by all persons while in market and maintain minimum 06 feet distance with each other.

9. Those persons and their family members who are under home quarantine and or houses have active case may be facilitated with essential services/food items etc. if any assistance required please contact at telephone numbers- 011-26704029, 8130573744.

If someone is experiencing any symptom, cold, flu-like or have returned from another location, may self-isolate himself/herself for 07 days; under intimation to the University Health Centre, Security Department and Administration at Telephone No.011-26741636, or Security Control Room at No. 011-26704029 or Administration at No. 011-26704008 (09 A.M. to 05 P.M.), 011-26704752 (24x7), In case of emergent situation, individual concerned may telephonically contact to the designated CMO of the CGHS dispensary inside the Campus for any further guidance or Ministry of Health and Family Welfare's 24X7 helpline at 011-23978046.
