## Office Order

In continuation to the Government of NCT of Delhi, Delhi Disaster Management Authority Order no. F.60/DDMA/COVI-19/2021/463 dated 30.08.2021, regarding the re-opening of educational institutes with maximum 50% of the seating capacity subject to strict compliance of SOPs notified by DDMA. The University decided phase-I reopening of the campus.

## 1. Phase-01 of Reopening of JNU from 06-Sept-2021:

- (i) *All Final Year PhD Research Scholars*, including 9B students (both hostellers and day-scholars) who are required to submit their PhD theses on/before **31.12.2021**, are allowed to enter into the campus.
- (ii) *All PwD(Persons with Disabilities) students* of the PhD program are allowed to enter into the campus.
- (iii) Dr. B.R. Ambedkar Central Library will be sanitized and seating arrangements of reading halls with 50% capacity is made before opening of the library.
- 2. The teaching/learning will continue to be in online mode.
- 3. School/Centre level libraries shall remain closed. After assessing the situation, the decision will be taken later.
- 4. Upon arrival on the campus, every student must fill-up and submit the Self-Declaration Form and adhere to the strict compliance of SOPs as per aforesaid DDMA order dated 30.08.2021.
- 5. Upon arrival on the campus, every student will produce a COVID-19 RT-PCR **negative test report** done within 72 hours. JNU Security will ensure the compliance.
- 6. For the implementation of re-opening of the university and Dr. B.R. Ambedkar Central Library, Standard Operation Procedure (SOP)/ precautionary measure, as notified by DDMA, will be adopted in addition to compliance of the measures/guidelines issued by Government from time to time.
- 7. Students, teachers and employees living in the containment zone are not allowed to come to the university campus.
- 8. Regular cleaning and sanitization of common areas and high touch surfaces will be ensured by the Estate Branch/IHA/Schools/Centres.
- 9. On campus counseling/ guidance of students and campus community will be conducted to give emotional/trauma support for their readiness with new normal of stringent physical distancing, face mask and hygiene guidelines.

- 10. No entry for any student/staff/teacher/guest without mask on the face is allowed in the university premises/building.
- 15. Any student suffering from any critical illness/ co-morbidity is advised not to visit the campus and continue to take the teaching/learning classes in online mode.
- 16. COVID-19 is reported to have a wide variety of symptoms ranging from mild to severe illness including fever or chills, cough, shortness of breath or difficulty in breathing, fatigue muscle or body aches, headache, loss of taste or smell, sore throat, congestion or runny nose, nausea or vomiting and diarrhea. Anyone having any such symptoms is advised to isolate herself/himself and report to the Health Centre.

Any person found violating the aforesaid instructions, shall be liable to be proceeded against as per the provisions of section 51 to 60 of Disaster Management Act, 2005, Section 188 of IPC and other applicable laws.

This issues with the approval of the Competent Authority.
