Conditions: -

1. The quotation for the work shall remain open for a period of 15 days from the date of opening of quotations.
2. The work shall be carried out as per specifications/make defined in the NIQ.
3. All taxes shall be deducted as per Govt. of India rules applicable.
4. Time allowed for completion of above work is **07 days**.
5. The contractor shall be debarred from the JNU works for one year, if contractor fails to take up the work and /or does not complete the work within the stipulated period.
6. Earnest Money amounting to **Rs.907/-** should be deposited in the shape of Pay Order/Banker's Cheque/Demand Draft in favour Finance Officer, JNU. No quotation will be entertained without Earnest Money.
7. Security deposit @7.5% of quoted amount shall be recovered from the bill (after adjusting EMD amount) and shall be refunded after warranty period of six months.
8. **The Quotation and the earnest money shall be placed in separate sealed envelopes, each marked, "Quotation" and "Earnest Money" respectively. Both the envelopes shall be submitted together in another sealed envelope with the name of work and due date of opening written on envelope. The envelopes marked, "Quotation" of only those Quotationers shall be opened, whose earnest money, placed in the other envelope, is found to be in order.**
9. The firm has to produce self attested copies of all relevant documents such as Electrical Contractor License, PAN no., GST Registration and experience certificate along with the quotation.
10. The contractor has to execute the work as per the schedule given by the JNU
11. The quoted rates shall be inclusive of all taxes, cartage etc and nothing shall be paid extra on / above quoted rates.
12. Payment shall be made after satisfactory completion of work.
13. The contractor shall be debarred from the JNU for one year if he withdraws his offer or fails to start the work before / after award of work.
